Registration Information and Procedures for International Students

Regular Full Time New International Student Registration

Thank you for your interest in the International Student Program at Calvin Christian Collegiate. We have enclosed the Course Catalogue and General Information booklet for your information. This document contains the information that differs for international students such as the international student fee structure and the application procedure.

The following documents must be completed and submitted by all new applicants for consideration for admission to Calvin Christian Collegiate International Student Program.

- ☐ Translated school reports for the last 2 years (photocopy or fax is sufficient for application but students must submit officially translated transcripts when they arrive)

Upon receipt of an application, Calvin Christian Collegiate will contact the applicant to arrange a time for a personal or telephone interview with the student and his/her parent(s)/guardian(s). Interviews will be arranged with applicants who meet the requirements of the International Student Program and are eligible for placement within the program. After the interview, applicants will be notified whether they have been accepted or not.

Once the school has received the tuition payment from an accepted student, the student will be formally admitted and given a letter of acceptance for immigration purposes.

Student and Family Qualifications

Calvin Christian Schools provides academic and religious education. It is our expectation that at least one parent is a practicing Christian and is an active member of a body of Christian believers. We require a letter of reference, translated into English, from a pastor or an elder (or equivalent) from the family church (form ISF 005). The parent(s) are expected to be able to articulate a statement of Christian faith in an interview setting, with or without the assistance of a translator. The prospective student must also articulate a statement of faith and signify agreement with the school's code of conduct.

Accommodations

- All international students not living with their parents must live with a home-stay family arranged or approved by the school.
- Students living with home-stay families must abide by the family rules.

Custodianship

All minor children living in Canada without a parent are required to have a legal custodian who is a permanent resident or citizen of Canada. We will send the proper documents (from Citizenship and Immigration Canada) which you are required to fill out. Students must submit proof of designated guardian (also necessary for visa application).
