Registration Information and Procedures for International Students

International Student Program

Thank you for your interest in the International Student Program at Calvin Christian School. All new applicants must submit the following for consideration for admission to Calvin Christian School.

- ☐ ISP 002 - Application For Admission
- ☐ ISP 003 - Student Homestay Application (if homestay is required)
- ☐ ISP 004 - Medical Form
- ☐ ISP 005 - Pastoral Reference Form
- ☐ Custodianship Declaration Form(s) – Custodian & Parent/Guardian (if applicable)
- ☐ Transcripts of the last two school years (translated)
- ☐ A letter of recommendation from the previous principal
- ☐ An electronic copy of a recent passport sized photo
- ☐ A non-refundable application fee of \$100 CDN.

Students must be able to demonstrate proficiency in the English language.

Upon receipt of an application, Calvin Christian School will contact the applicant to arrange a time for a personal or telephone interview with the student and his/her parent(s)/guardian(s). Interviews will be arranged with applicants who meet the requirements of the International Student Program and are eligible for placement within the program. After the interview, applicants will be notified whether or not they have been accepted.

Once the school has received payment of at least half of the tuition amount from an accepted student, the student will be formally admitted and given a letter of acceptance for immigration purposes.

Fee Structure

Student and Family Qualifications

Calvin Christian School provides academic *and* religious education. It is our expectation that at least one parent is a practicing Christian and is an active member of a body of Christian believers. We require a letter of reference, translated into English, from a pastor or an elder (or equivalent) from the family church (form ISP 005). The parent(s) are expected to be able to articulate a statement of Christian faith in an interview setting, with or without the assistance of a translator. The prospective student must also articulate a statement of faith and signify agreement with the school's code of conduct.

Accommodations

- All international students not living with their parents must live with a Homestay family arranged or approved by the school.
- Students living with Homestay families must abide by the family rules.

Custodianship

All minor children living in Canada without a parent are required to have a legal custodian who is a permanent resident or citizen of Canada. The Custodianship Declaration forms for parent/guardian and custodian must be completed and submitted with the application package (available on our website). This is necessary for visa application.

On arriving at school

Students must submit the following:

- ☐ Photocopy of first page of passport
- ☐ Photocopy of study permit
- ☐ Photocopy of the passport page where stamp was placed by immigration officer
- ☐ Certified and translated school reports for the last 2 years
